

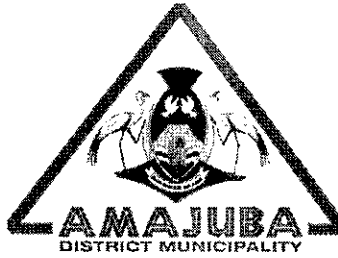

PROVISION OF WAN, INTERNET AND VOIP SERVICES

TERMS OF REFERENCE

1. INTRODUCTION

Bids are hereby invited from ICASA and ECS licensed service providers to provide WAN, Internet and VOIP services for a period of 3 years, and for the supply of required equipment.

2. BACKGROUND

ADM requires the provision of WAN, Internet and VOIP services at its sites in the Amajuba District Municipal Area for a period of 3 years.

Bidders are required to describe in detail the proposal to be employed, which will illustrate what approach will be used ;and why they believe that approach is best suited to achieve the Project's objectives.

3. LEGISLATIVE FRAMEWORK REQUIREMENTS

Bids are requested from ICASA registered ECS license holders, in line with the Electronic Communications Act of 2005. Proof of registration must be attached, failure to attach will result in bids not be considered.

4. AIM AND OBJECTIVES OF THE PROJECT

- i. To provide WAN services linking remote sites to the Amajuba District Municipality main site in Madadeni to provide connectivity to services.
- ii. This a turnkey project.
- iii. To provide measurably reliable Internet access to all identified sites.
- iv. To provide VoIP telephone services to all identified sites, with the goals of reducing telephone service costs, and simplifying management of the telephone services

5. SPECIAL CONDITIONS

- i. After appointment, 2 months are available for implementation before services are expected to go live.
- ii. Detailed annual cost breakdown for 3 years must be included in bid documents.
- iii. Company profile of bidder must be included.

6. PROJECT MANAGEMENT STRUCTURES

6.1 PROJECT MANAGEMENT TASK TEAM

The Service Provider will report to the Project Management Task Team which comprise of relevant DC25 officials.

6.2 PROJECT STEERING COMMITTEE

The Project Management Task Team will report to the project steering committee responsible for the management of the project progress as and when required by the project steering committee.

7. SCOPE OF WORK

7.1 Provide and set-up all required WAN infrastructure for the provision of the services.

This will include routers, radios, antennas and all other required infrastructure. Infrastructure related to the provision of the service will remain the property of the successful service provider, and management thereof will form part of the responsibilities of the service provider. The cost for the provision of this equipment must be included in the monthly fee to be billed to Amajuba District Municipality.

7.2 Provide additional equipment that Amajuba District Municipality will require to make use of the service. This equipment will become the property of the Municipality upon the date of the service provider receiving payment for the same. This includes:

- 7 entry level desktop computers with the following specifications
 - Entry level processor (i.e. Intel Celeron)
 - 500GB hard drive
 - 4 GB RAM
 - Windows 10 Professional
- 100 VoIP phones

7.3 Provide a hosted and fully managed PBX service with the following features:

- Migrate ADMs current number range (034 329 7200 – 034 329 7400)
- 170 extensions
- Per extension cost reporting
- Online management
- A combined estimated usage of 5 000 minutes per month.

7.4 Set up equipment to access the services. This will include:

- setting up 100 new VoIP phones provided by the service provider
- setting up 70 existing VoIP phones at Amajuba (Aastra 6731i)
- firewall and routing to allow required network connectivity

8. REQUIRED EXPERTISE, SKILLS AND KNOWLEDGE

Bidders will be required to provide at least 2 contactable references of similar work done including

- Set up of multi-site WAN connected sites
- Provision of reliable internet services in line with the required up-time of 99%
- Provision of VoIP services

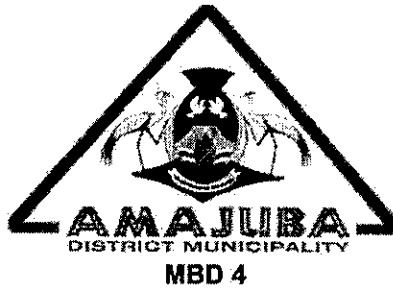

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value up to R50 000 000; and

1.2 The value of this bid is estimated not to exceed R50 000 000 and therefore the 80/20 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution

1.3.1 The maximum points for this bid are allocated as follows:

Separate Preference Points Claim Forms will be used for the promotion of the specific goals for which points have been allocated in paragraph 1.3.1.2 (b) above.

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or

a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

- 1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2.

DEFINITIONS

- 2.1.1 “**all applicable taxes**” includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 “**B-BBEE**” means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 “**B-BBEE status level of contributor**” means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 “**comparative price**” means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less .
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**sub-contract**” means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;

- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{\min} = Comparative price of lowest acceptable bid

5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

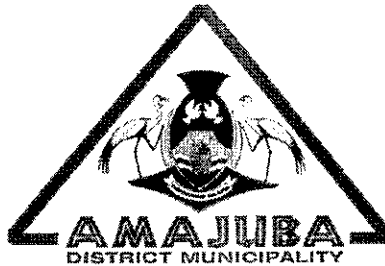

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

Bid rigging is, therefore, an agreement between competitors not to compete.
