THE CONSTRUCTION OF BULK WATER AND SANITATION SERVICES FOR DANNHAUSER HOUSING DEVELOPMENT

Bids are hereby invited from contractors registered on the Central Supplier Database (CSD) with CIDB grading of 7CE or higher class of construction works for the construction of Bulk water and sanitation services for the Dannhauser housing development project. Regulation 4 is applicable for this bid, bidders will be pre-qualified on the basis of BBEE status level contributor, level 1, Only bidders who qualify as BBEE level 1 will be considered for this bid. The 80/20 preference point system will be applicable as prescribed in Amajuba District Municipality Supply Chain Management Policy.

Bidders will be evaluated in terms of functionality as part of the minimum requirements before evaluated on price based on the following criteria: A bid that scores less than 70 points out of 100 in respect of functionality will be regarded as non-responsive. Thereafter the 80/20 Preference Points system will be applicable, with 80 points for price and 20 points for B-BBEE Status Level of Contribution. NB: Bidders are required to submit original tax clearance certificate/ Tax Compliance Status Pin or CSD number and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims. Failure to submit the proof of B-BBEE Certificate will result to a disqualification.

Bid documents will be made available as from **29th of July 2019** to the **6th August 2019** at the SCM Unit of the Amajuba District Municipality upon producing proof of payment of a non-refundable fee of **R500.00** per document. Deposits must be made to the Amajuba District Municipality bank account: **ABSA Bank Account No. 4053472593 with the number obtained from the Amajuba District Municipality as a reference.** Bidders will be required to produce proof of the deposit before they will be issued a bid document. Cash payments will not be accepted at the Amajuba offices. **NB: Bid documents must be reserved in advance to obtain a reference number from Khethiwe Msimango at Amajuba District Municipality on 034-329 7200 or by email khethiwem@amajuba.gov.za on or before 6th of August at 12h00 noon.** Bidders who do not reserve documents before this time will not be allowed to collect documents at the Compulsory Clarification Meeting. Documents must be collected before or on the date of the Compulsory Clarification Meeting as no documents will be issued after the day of the clarification meeting. Bidders failing to attend the clarification meetings will be disqualified.
