Amajuba District Municipality hereby call for proposals from Registered Companies in terms of the Engineering Profession Act 2000 (act no. 46 of 2000) for Civil Engineering Services, who were appointed as Professional Service Providers to the Amajuba District Municipality on the panel of professional service providers (PSP's) under the call for expression of interest E2017/01. Only bidders who qualify as BBBEE level 1 will be considered for this bid.


NB: This bid will be evaluated on price and functionality in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and for this purpose the enclosed forms must scrutinized, completed and submitted together with your bid. The tender validity period is 90 days after tender closing date.

Bidders are required to submit original tax clearance certificate/ Tax Compliance Status Pin or CSD number and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims. Failure to submit the proof of B-BBEE Certificate will result in forfeiting the points.

### Part E.3

#### Scope of works

The main aim of this request is to appoint professional service providers for Amajuba District Municipality, to provide professional services for the design and construction monitoring of the following project:

1. Zaaihoek Water Treatment Upgrade and Bulk Water pipeline. It is estimated at **R90 Million** to calculate professional fees and no percentages will be allowed.

Successful bidder will be required to do business plan to source the capital budget for undertaking the project feasibility, preliminary and detailed design and tender documentation, the construction monitoring and actual construction budget will be sourced by compiling a business plan to Department of Water and Sanitation and to Cooperative Governance and Traditional Affairs.

Bidder must note that these projects will be implemented in the 2019/20 and beyond financial years, and each with expected construction duration of approximately 36 months depending on the complexity. The Business plan cost is to be undertaken at risk until budget is approved and released for expenditure.

The indicative scope of work of the appointed Professional Service Provider (PSP) will be as follows:

1. Preparation of Business Plans follow up and liaison with DWS and COGTA until approval is granted.
2. Geotechnical investigation
3. Undertake any topographical surveys required.
4. Undertake Environmental Management Plans, and sort EIA, BA and WULA Licenses.
5. Undertake Institutional Social Development (ISD) program.
6. Prepare preliminary and detail designs and producing of drawings for consideration and approval by Amajuba District Municipality.
7. Prepare all necessary tender documents and attend compulsory briefing session.
8. Prepare tender evaluation report.
9. Manage the contract to undertake the project including the preparation of contractor payments using the applicable systems of Amajuba District Municipality.
10. Undertake any quality assurance required
11. Attendance of the professional team meetings.
12. Prepare and maintain a consultant payment schedule to keep track of all Fee Claims, which will be submitted with each claim.
13. Prepare a monthly project report
14. Prepare Hand Over certification and Close out.
15. Preparation of As-built drawings and submission in GIS format.
16. Development of necessary safety plans to ensure compliance to OHSA.



- 2.11. **"functionality"** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12. **"non-firm prices"** means all prices other than "firm" prices;
- 2.13. **"person"** includes a juristic person;
- 2.14. **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15. **"sub-contract"** means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;

- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

### 3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

### 4. POINTS AWARDED FOR PRICE

#### 4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

#### 80/20

$$P_s = 80 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

- $P_s$  = Points scored for comparative price of bid under consideration
- $P_t$  = Comparative price of bid under consideration
- $P_{\min}$  = Comparative price of lowest acceptable bid

### 5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

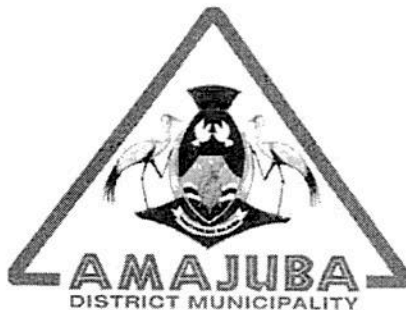

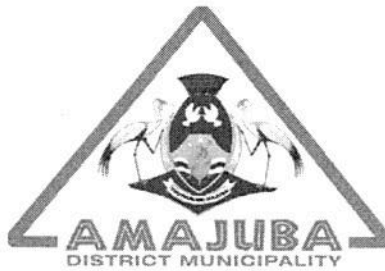
