1. INTRODUCTION

Municipalities are required in terms of Chapter V of the Municipal Systems Act (MSA) 32 of 2000 to prepare and adopt Integrated Development Plans (IDPs) for the areas under their jurisdiction. Thus, section 25 (1) states that: "Each municipal Council must within a prescribed period after the start of its elected term, adopt a single, inclusive and strategic plan for the development of the municipality..."

The Municipality intends to appoint a competent service provider to facilitate an intense strategic planning process for council aimed at enhancing good governance, service delivery and financial viability. The process is also intended at providing the basis for the review of the IDP/Budget process and is expected to result in the development of a diagnostic report; an assessment and analysis of the current vision and mission; review of the IDP objectives; strategies and key performance indicators to ensure that they conform to the SMART principle. Ultimately the planning process must culminate in the compilation of a consolidated strategic planning session with clear deliverables as per the Terms of Reference contained in this specification document.

2. BACKGROUND

A strategic plan sets out a Municipality's policy priorities, programmes and project plans for a certain period of time as approved by its executive authority within the scope of available resources. The strategic plan also focuses on strategic outcomes-oriented goals for the Municipality as a whole, and objectives for each of its main service-delivery areas aligned to its budget programmes.

Strategic plans focus on issues that are strategically important, linked to and flowing from various plans developed within Municipality's to fulfil their mandates. Operational issues such as the Municipality's finances, supply chain management, information systems or human resources can be considered strategic priorities if they are aimed at facilitating improved performance. The primary focus should be on the Municipality's outputs, outcomes and impacts.

It is pivotal to provide transparency and accountability to the communities that we serve. The IDP serves as a public document that communicates the municipality's plans and intentions for a period of five years. Thus, the municipality currently seeks to review its Key Performance Indicators (KPI's) so as to ensure clarity, and specificity to the general public. The strategies and objectives that are well formulated may also assist in tracking implementation and evaluation thereof.

3. TARGET GROUP

The strategic planning session will be held with council (30 councilors) inclusive of members of the Executive Committee, senior managers, and representatives of trade unions.

4. PURPOSE

Based on the legislative requirements, the Municipality is seeking a competent service provider to facilitate the Strategic Planning Session (preparatory session with administration and the final strategic

planning session with all stakeholders), for the annual review of the five (5) year IDP. The purpose of the review is to ensure an evaluation of the Municipality al objectives, strategies and the key KPI's, therefore ensuring alignment with the KPI information concepts (inputs, activities, outputs, outcomes and impacts) and the Specific, Measurable, Achievable, Relevant and Time-bound (S.M.A.R.T) principles.

Furthermore, the successful service provider will be required to incorporate the audit findings by the Auditor General in the facilitation of the Strategic Planning Session.

5. QUALIFICATIONS AND EXPERTISE REQUIRED

- 5.1 Only bidders with B-BBEE Level 1 status of contributor may submit bids for this invite
- 5.2 The Facilitator must be a Chartered Accountant and proof of registration (SAICA certificate) must be submitted.
- 5.3 Proof of previous experience in facilitation of strategic planning sessions not older than five (5) years and proof of appointment in the form of appointment letter or purchase order to accompany the bid submission.

6. SCOPE OF WORK

The service provider must:

- 6.1 Analyse the current IDP;
- 6.2 Facilitate a two-day strategic planning session (preparatory session);
- 6.3 Facilitate a two-day strategic planning session (final);
- 6.4 Assess and analyse the IDP objectives, strategies and KPI's and ensure that they conform to the S.M.A.R.T principle;
- 6.5 Identify areas of improvement;
- 6.6 Incorporate the Auditor General findings in the Strategic Planning Session; and
- 6.7 Provide a strategic planning report.

7. REQUIRED OUTCOMES

- 7.1 Strategic objectives that clearly state what the Municipality ought to perform to achieve its strategic outcomes goals.
- 7.2 Strategic outcomes-oriented goals that focus on impacts and outcomes (A strategic outcomes-oriented goal should ideally be written as a statement of intent that is S.M.A.R.T.
- 7.3 Each objective should be written as a performance statement that is S.M.A.R.T and must set a performance target that the Municipality can achieve by the end of the period of the strategic plan.
- 7.4 Each strategic objective must describe things that the Municipality is directly responsible for doing or delivering under its respective programmes and sub-programmes.

8. DELIVERABLES

The expected outputs of this exercise are:

- 8.1 The facilitation of Strategic Planning Session;
- 8.2 The Strategic Planning Session must take place within 14 days of the successful bidder receiving appointment letter;
- 8.3 The first draft of the strategic planning document must be submitted to the municipality within five (5) working days after hosting the strategic planning session;
- 8.4 To assess and make recommendations on the alignment of the IDP, Budget to the Municipal-wide and Departmental SDBIPs;
- 8.5 The successful service provider will be required to produce a report with recommendations on addressing 2018 2019 Auditor General's findings.
- 8.6 The final report to be submitted to the Municipality within 14 after the Strategic Planning Session.


9. GENERAL

The Municipality will provide the venue and refreshments for the for the sessions.

10. EVALUATION WILL BE BASED ON THE FOLLOWING:

This bid will be evaluated on price in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (**No 5 of 2000**) and for this purpose the enclosed forms must be scrutinized, completed and submitted together with your bid. The bid validity period is 90 days after tender closing date.

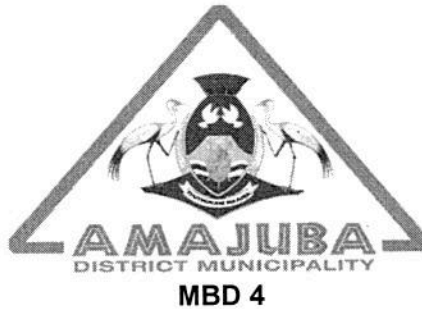

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value up to R50 000 000; and

1.2 The value of this bid is estimated not to exceed R50 000 000 and therefore the 80/20 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution

1.3.1 The maximum points for this bid are allocated as follows:

Separate Preference Points Claim Forms will be used for the promotion of the specific goals for which points have been allocated in paragraph 1.3.1.2 (b) above.

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS)

Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

- 1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

DEFINITIONS

- 2.1. **"all applicable taxes"** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2. **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3. **"B-BBEE status level of contributor"** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4. **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5. **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6. **"comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7. **"consortium or joint venture"** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8. **"contract"** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9. **"EME"** means any enterprise with an annual total revenue of R5 million or less .
- 2.10. **"Firm price"** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11. **"functionality"** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12. **"non-firm prices"** means all prices other than "firm" prices;
- 2.13. **"person"** includes a juristic person;
- 2.14. **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15. **"sub-contract"** means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;

2.16. **"total revenue"** bears the same meaning assigned to this expression in the Codes of Good

Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;

- 2.17 “**trust**” means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 “**trustee**” means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{\min} = Comparative price of lowest acceptable bid

5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.

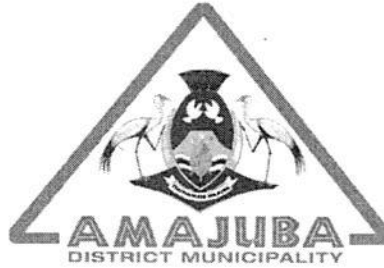
